There will be no resets within a class per UKC nosework regulations. Only one dog per class or element, per handler. Entries with multiple dogs, same handler, in the same class will be returned. For example, you may run one dog in novice vehicles, and another in advanced vehicles, but the same handler cannot run two dogs in novice vehicles in the same trial.

COVID 19

These trials will be held in accordance with UKC's suggested practices and in compliance with State of Michigan and local COVID 19 guidelines and regulations.

The trial schedule may change so all exhibitors are not at the trial site at the same time, and exhibitors may need to crate/run their dog from their vehicle. Exhibitors, judges and volunteers will be notified of the specific requirements as the trials draw closer.
